Purpose: The General Manager: Supply Chain Management reports directly to the Executive Manager: Financial Services. The incumbent in this position will be responsible for managing the demand and acquisition of all products and service as well as coordinating and controlling the logistics related to the distribution of all stock/products. The incumbent will also be responsible for managing and controlling assets, inventory and the fleet of Vehicles owned by the RTMC. The incumbent will approve orders, invoices, expenses and fuel claims within approved authorisation limits for final processing and therefore ensuring compliance with all budgetary guidelines and RTMC Supply Chain and Financial Policy requirements. The incumbent will also be responsible for the development, implementation and maintenance of a supply chain management system.

Requirements: A Bachelor's Degree or Equivalent qualification is essential, a relevant post-graduate qualification would be an added advantage. Candidate must possess at least 8 years' experience in a Supply Chain Management related role of which 4 years at a management level.
