LIMPOPO TRAFFIC OFFICER FOUND GUILTY ON CORRUPTION CHARGES

A Mokopane Traffic Officer, Vincent Madiga, was found guilty on corruption charges when he appeared at the Mokopane Magistrate Court on Tuesday 8 August 2023. This follows his arrest for soliciting a R200 bribe from an under-cover Agent during operation Siyabangena on 19 May 2019 along the N1 in the Limpopo province.

During the court proceedings audio and video evidence was provided. Upon completion of the proceedings the court concluded that the state had proved its case beyond reasonable doubt therefore finding Madiga guilty on all charges laid against him. This was despite the defence challenging the constitutionality of the video evidence. The matter was postponed to 29 September 2023 for pre-sentencing procedures.
