# **SECTION: 1**

# CONDITIONS AND UNDERTAKINGS BY BIDDER IN RESPECT OF THIS BID

### 1. Proprietary Information

Road Traffic Management Corporation (RTMC) considers this bid and all related information, either written or verbal, which is provided to the bidder, to be proprietary to RTMC. It shall be kept confidential by the bidder and its officers, employees, agents and representatives. The bidder shall not disclose, publish, or advertise this specification or related information to any third party without the prior written consent of RTMC.

# 2. Enquiries

- 2.2 All the documentation submitted in response to this bid must be in English.
- 2.3 No enquries for this bid shall be entertained nor be responded to post the compulsory briefing session. All enquiries will be consolidated and posted to the RTMC website under bids next to the same bid.
- 2.4 The RTMC may respond to any enquiry in its sole discretion and the bidder acknowledges that it will have no claim against the RTMC on the basis that its bid was disadvantaged by lack of information, or inability to resolve ambiguities.

### 3. Validity Period

Responses to this bid received from bidders will be valid for a period of **120 days** counted from the closing date of the bid.

### 4. Supplier Performance Management

- 4.1 Supplier Performance Management is viewed by the RTMC as critical component in ensuring value for money acquisition and good supplier relations between the RTMC and all its suppliers.
- 4.2 The successful bidder shall upon receipt of written notification of an award, be required to conclude a Service Level Agreement (SLA) with the RTMC, which will form an integral part of

the agreement. The SLA will serve as a tool to measure, monitor and assess the supplier's performance level and ensure effective delivery of service, quality and value-add to RTMC business.

#### 5. Instructions on submission of Bids

- 5.1 Bids should be submitted in **Five (5) copies** and one all bound in a sealed envelope endorsed, RTMC BID 01/2016/17: Appointment of a service providers to supply and deliver branded bottled water for a period of three (3) years to the Road Traffic Management Corporation.
- 5.2 The sealed envelope must be placed in the bid box at the Main Reception area of the RTMC Building, Boardwalk Office Park, Boardwalk Boulevard, Phase 5, Faerie Glen, Pretoria East by no later than 11:00 AM on 16 May 2016.
- 5.3 A valid tax clearance certificate must be included in the bid response, or proof of application endorsed by SARS in this regard.
- 5.4 The bidder's company name, closing date and the return address must also be endorsed on the envelope.
- 5.5 All bids submitted must be signed by a person or persons duly authorised thereto.
- 5.6 If a courier service company is being used for delivery of the bid document, the bid description must be endorsed on the delivery note/courier packaging to ensure that documents are delivered into the bid box. The RTMC will not be held responsible for any delays where documents are not placed in the bid box before closing time.
- 5.7 Bid received by telegram, telex, email, facsimile or similar medium will not be considered.
- 5.8 Where a bid document is not placed in the bid box at the time of the bid closing, such a bid document will be regarded as a late bid. Late bids will not be considered.
- 5.9 Amended bids may be sent in an envelope marked "Amendment to Bid" and should be placed in the bid box before the closing time.

5.10 Bidders should check the numbers of the pages to satisfy themselves that none are missing or duplicated. No liability will be accepted by RTMC in regard to anything arising from the fact that pages are missing or duplicated.

# 6. Undertakings by the Bidder

- 6.1 The bidder accepts that all costs incurred in preparation, presentation and any demonstration in relation to this bid shall be for the account of the bidder.
- 6.2 The bidder hereby offer to render all or any of the services described in the attached documents to the RTMC on the terms and conditions and in accordance with the specifications stipulated in this bid documents (and which shall be taken as part of, and incorporated into, this proposal at the prices inserted therein).
- 6.3 The bidder shall prepare for a possible presentation should RTMC require such and the bidder shall be notified thereof no later than 4 (four) days before the actual presentation date. Such presentation may include demonstration of products or services as called for by the RTMC in relation to this bid.
- 6.4 The successful bidder hereby accept full responsibility for the proper execution and fulfilment of all obligations and conditions devolving on him/her under this agreement as the principal(s) liable for the due fulfilment of this contract.
- 6.5 The bidder furthermore confirm that he/she has satisfied himself/herself as to the correctness and validity of his/her bid response that the price(s) and rate(s) quoted cover all the work/item(s) specified in the bid response documents and that the price(s) and rate(s) cover all his/her obligations under a resulting contract and that he/she accept that any mistakes regarding price(s) and calculations will be at his/her risk

# 7. RTMC's Rights

7.1 The RTMC reserves the right not to accept the lowest bid or any bid in part or in whole. RTMC normally awards the contract to the bidder who proves to be fully capable of handling the contract and whose bid is technically acceptable and/or financially advantageous to the RTMC.

- 7.2 The RTMC also reserves the right to award this bid as a whole or in part without furnishing reasons.
- 7.3 The RTMC reserves the right to conduct a site visit at the premises of the offices or at any client sites if so required.
- 7.4 The RTMC reserves a right to amend any bid conditions, validity period, specifications, or extend the closing date of bid prior to the initially stated closing date. Bidders will be advised in writing of such amendments in good time.
- 7.5 The RTMC reserves the right to request all relevant information, agreements and other documents to verify information supplied in the bid response. The bidder hereby gives consent to the RTMC to conduct background checks on the bidding entity and any of its directors/trustees/shareholders/members.

## 8. Supplier Development and Promotion of Emerging Black Owned Service Provider

- **8.1** The RTMC promotes enterprise development In this regard, successful bidders are encouraged to mentor SMME's and/or Youth owned businesses. The implications of such arrangement will be be subject to negotiations between the RTMC and the successful bidder.
- 8.2 It is also the objective of the RTMC to promote transformation of the South African economy and as such, bidders are encouraged to partner with a black owned entity (being 50%+1 black owned and controlled). Such partnership may include the formation of a Joint Venture and/ or subcontracting agreement etc., where a portion of the work under this bid would be undertaken by black owned entities.
- 8.3 To give effect to this requirement, bidders are required to submit a partnership/ subcontracting proposal detailing the portion of work to be outsourced, level of involvement of the black owned partner and where relevant, submit a consolidated B-BBEE scorecard in-line with the provisions of the PPPFA Regulations which will be considered as part of the B-BBEE scoring.

## 11. SPECIAL INSTRUCTIONS TO BIDDERS

**11.1** Bidders shall provide full and accurate answers to the questions posed in this document.

- **11.2** Bidders **must** substantiate their response to all questions, including full details on how their proposal/solution will address specific functional/technical requirements. All documents as indicated must be supplied as part of the bid response.
- **11.3** RTMC reserves the right to appoint more than one service provider in order to ensure prompt delivery and efficiency of the service.
- **11.4** Bidders are required to provide samples to the RTMC, failure to provide such will lead to the bid being no-responsive.
- **11.5** RTMC reserves the right to contact shortlisted bidders to negotiate a flat rate as determined by the RTMC.
- **11.6** Bidders must provide a sample of the bottled water. The following are critical requirements in relation to a sample:
  - 11.6.1 Proof of certification of water contents should be outlined on label
  - 11.6.2 Bidders must provide details of water distributor and matters that relates to quality assurance and the legislature requirements e.g SABS approval.
  - 11.6.3 Labelling/Branding of containers must be in line with the minimum required labelling requiremnts on bottled water. (where bidders do not have internal labelling capacity, details of service provider where labelling will be done must be provided).

### 12. EVALUATION CRITERIA

The bid will be evaluated on a two stage process. Stage 1 will be on Functionality and Stage 2 will be on 90/10 Preference Point System (i.e. Price and B-BBEE).

## (a) Stage 1 – Functionality Evaluation

Stage 1 will evaluated on functionality based evaluation criteria provided in 12.1 below. Bidders must obtain a **minimum of 70 points** to proceed to the stage 2 of the

evaluation. Bidder's who fail to meet the minimum threshold will be disqualified from further evaluation.

### **SECTION 2: TECHNICAL REQUIREMENTS/ SPECIFICATION**

### 1. PURPOSE

The purpose of this bid is to invite potential service provider/s with relevant expertise and capacity to supply the Road Traffic Management Corporation (RTMC) with branded bottled water for a period of three (3) years from date of appointment.

# 2. OVERVIEW

The Corporation makes use of water during meetings, activities and operations in pursuit of its strategic mandate. As Public Entity which is an agency of the Department of Transport responsible for road traffic management in the Republic of South Africa, the Corporation often organize events, activities and coordinate operations that sometimes happen far from amenities. As a result water is the least commodity that can be offered to guests, stakeholders and clients of the Road Traffic Management Corporation in meetings, activations and operations that the RTMC coordinates. The RTMC brand is not well known, thus it needs to be grown to a well known and easily recognised brand within the road traffic management fraternity and the general public.

#### 3. OBJECTIVE

The main objective of acquiring water is for the purpose of hospitality to the RTMC's guests, stakeholders and to promote the RTMC brand across the country at events, activations and operations coordinated by the Road Traffic Management Corporation.

As it may not be advisable to keep huge quantities of water in storage due to both the shortage of storage facilities and ensuring that the water is fresh and suitable for consumption, it will be required that the water supplied be bottled nearest the date of delivery and utilization. The supplier may be required to have the capacity to supply at least 10 000 bottles of water at short notice and delivery to any place within the borders of South Africa.
