1. **Proprietary Information**

2. **Enquiries**

- 2.2 All the documentation submitted in response to this bid must be in English.
- 2.3 The RTMC may respond to any enquiry in its sole discretion and the bidder acknowledges that it will have no claim against the RTMC on the basis that its bid was disadvantaged by lack of information or inability to resolve ambiguities.

3. **Validity Period**

Responses to this bid received from bidders will be valid for a period of **120 days** counted from the closing date of the bid.

4. **Supplier Performance Management**

- 4.1 Supplier Performance Management is viewed by the RTMC as critical component in ensuring value for money acquisition and good supplier relations between the RTMC and all its suppliers.
- 4.2 The successful bidder shall upon receipt of written notification of an award, be required to conclude a Service Level Agreement (SLA) with the RTMC, which will form an integral part of the agreement. The SLA will serve as a tool to measure, monitor and assess the supplier's performance level and ensure effective delivery of service, quality and value-add to RTMC business.

5. **Instructions on submission of Bids**

- 5.1 Bids should be submitted in **Five (5) copies** and one all bound in a sealed envelope endorsed, **RTMC BID 04/2016/17: Appointment of a Recruitment Agency for a period of a year.**
- 5.2 The sealed envelope must be placed in the bid box at the Main Reception area of the RTMC Building, Boardwalk Office Park, Boardwalk Boulevard, Phase 5, Faerie Glen, Pretoria East by no later than **11:00 AM on 17 January 2017.**
- 5.3 A valid tax clearance certificate must be included in the bid response or proof of application endorsed by SARS in this regard.
- 5.4 The bidder's company name, closing date and the return address must also be endorsed on the envelope.
- 5.5 All bids submitted must be signed by a person or persons duly authorised thereto.
- 5.6 If a courier service company is being used for delivery of the bid document, the bid description must be endorsed on the delivery note/courier packaging to ensure that documents are delivered into the bid box. The RTMC will not be held responsible for any delays where documents are not placed in the bid box before closing time.
- 5.7 Bid received by telegram, telex, email, facsimile or similar medium will not be considered.
- 5.8 Where a bid document is not placed in the bid box at the time of the bid closing, such a bid document will be regarded as a late bid. **Late bids will not be considered.**
- 5.9 Amended bids may be sent in an envelope marked "**Amendment to Bid**" and should be placed in the bid box before the closing time.
- 5.10 Bidders should check the numbers of the pages to satisfy themselves that none are missing or duplicated. No liability will be accepted by RTMC in regard to anything arising from the fact that pages are missing or duplicated.

6. Undertakings by the Bidder

- 6.1 The bidder accepts that all costs incurred in preparation, presentation and any demonstration in relation to this bid shall be for the account of the bidder.
- 6.2 The bidder hereby offer to render all or any of the services described in the attached documents to the RTMC on the terms and conditions and in accordance with the specifications stipulated in this bid documents (and which shall be taken as part of, and incorporated into, this proposal at the prices inserted therein).
- 6.3 The bidder shall prepare for a possible presentation should RTMC require such and the bidder shall be notified thereof no later than 4 (four) days before the actual presentation date. Such presentation may include demonstration of products or services as called for by the RTMC in relation to this bid.
- 6.4 The successful bidder hereby accept full responsibility for the proper execution and fulfilment of all obligations and conditions devolving on him/her under this agreement as the principal(s) liable for the due fulfilment of this contract.
- 6.5 The bidder furthermore confirm that he/she has satisfied himself/herself as to the correctness and validity of his/her bid response that the price(s) and rate(s) quoted cover all the work/item(s) specified in the bid response documents and that the price(s) and rate(s) cover all his/her obligations under a resulting contract and that he/she accept that any mistakes regarding price(s) and calculations will be at his/her risk

7. RTMC's Rights

- 7.1 The RTMC reserves the right not to accept the lowest bid or any bid in part or in whole. RTMC normally awards the contract to the bidder who proves to be fully capable of handling the contract and whose bid is technically acceptable and/or financially advantageous to the RTMC.
- 7.2 The RTMC also reserves the right to award this bid as a whole or in part without furnishing reasons.
- 7.3 The RTMC reserves the right to conduct a site visit at the premises of the offices or at any client sites if so required.

- 7.4 The RTMC reserves a right to amend any bid conditions, validity period, specifications or extend the closing date of bid prior to the initially stated closing date. Bidders will be advised in writing of such amendments in good time.
- 7.5 The RTMC reserves the right to request all relevant information, agreements and other documents to verify information supplied in the bid response. The bidder hereby gives consent to the RTMC to conduct background checks on the bidding entity and any of its directors/trustees/shareholders/members.

8. Supplier Development and Promotion of Emerging Black Owned Service Provider

- 8.1 The RTMC promotes enterprise development In this regard, successful bidders are encouraged to mentor SMME's and/or Youth owned businesses. The implications of such arrangement will be be subject to negotiations between the RTMC and the successful bidder.
- 8.2 It is also the objective of the RTMC to promote transformation of the South African economy and as such, bidders are encouraged to partner with a black owned entity (being 50%+1 black owned and controlled). Such partnership may include the formation of a Joint Venture and/ or subcontracting agreement etc., where a portion of the work under this bid would be undertaken by black owned entities.
- 8.3 To give effect to this requirement, bidders are required to submit a partnership/ subcontracting proposal detailing the portion of work to be outsourced, level of involvement of the black owned partner and where relevant, submit a consolidated B-BBEE scorecard in-line with the provisions of the PPPFA Regulations which will be considered as part of the B-BBEE scoring.

11.2 Bidders **must** substantiate their response to all questions, including full details on how their proposal/solution will address specific functional/technical requirements. All documents as indicated must be supplied as part of the bid response.

11.3 RTMC reserves the right to appoint more than one service provider in order to ensure prompt delivery and efficiency of the service.

12. EVALUATION CRITERIA

The bid will be evaluated on a three stage process. Stage 1 on mandatory requirements , Stage 2 will be on Functionality and Stage 3 will be on 90/10 Preference Point System (i.e. Price and B-BBEE).

(a) Stage 1 – Mandatory requirements

Bidders who fail to meet the mandatory requirements will be disqualified from further evaluation.

(b) Stage 2 – Functionality Evaluation

A two step process will be used which comprises of written responses/ proposals and presentation.

Step 1 will be on written responses/proposals which consists of **70 points**.

NB:Bidders will be required to score a min of **50 points** in order to qualify for Stage 2

Step 2 will be based on presentation which consist of **30 points**.

Bidders will be required to make a presentation before the evaluation committee.

NB : Bidders will finally be required to score at least **70 points** on functional evaluation in order to qualify for stage 3.

(c) Stage 3 – Price and Preference Points Evaluation

Stage 3 will be evaluated on a 90/10 Preference Point System (i.e. 90 points on Price and 10 points on B-BBEE).

SECTION 2: TECHNICAL REQUIREMENTS/ SPECIFICATION

2.1. PURPOSE

The Road Traffic Management Corporation would like to invite suitably qualified and experienced service providers to submit proposals for the provision of competency based recruitment services.

2.2. SCOPE OF WORK

2.2.1. The Human Capital Department plays an important role in the recruitment, selection and placement of suitable and highly skilled employees for the RTMC. To be able to provide this service to the Corporation, the Human Capital department requires the assistance and services of talent acquisition service provider with the relevant experience in sourcing of the skills which the Corporation needs to deliver on its mandate.

2.2.2. The purpose of this bid is to appoint a preferred talent acquisition service provider to provide on a need basis the services but not limited to following:

- Permanent placements;
- Temporary placements;
- Targeted placement of people with disabilities (across all levels)
- Learnship placements
- Search and Headhunting of key leadership, managerial, or specialist positions, and
- Response Handling

2.2.3. The Road Traffic Management Corporation is a values-based employer and therefore requires a recruitment agency that have experience in both sourcing appropriate technically skilled candidates and candidates that demonstrate a values match with the corporate culture of the Road Traffic Management Corporation.

2.2.4. The RTMC requires skilled and competent personnel which includes amongst others the following:

- Traffic Engineers
- Researchers
- Road Safety Researchers
- Road Safety Auditors

- Road Safety Crash Reconstruction
- Examiners of Vehicles
- Crash Investigator and Reconstruction Experts

2.2.5. The recruitment and placement process may include amongst others the following:

- Sourcing of suitable candidates as per job specification provided by RTMC
- Pre-Screening of all potential candidates, (i.e. interviews, employment checks, ITC, criminal and qualifications checks)

- Progress and Interview Reports

b) Head Hunting should cover atleast the following:

- Candidate profiling
- Candidate report presentation
- Reference checking

- Conduct background checks on candidates who passed pre-screening in line with RTMC requirements (e.g. Employment checks, Criminal checks and Qualifications checks etc.)
- Scheduling and interviewing the shortlisted candidates
- Report on outcome

2.2.6. The following is expected as a **minimum** to be submitted to the RTMC after completion of each placement process:

- The candidate's ID number and details must be provided for each application (more like applicants database)
- Criteria of selection in line with the requirements as per the job description
- Shortlisted candidate's certified copies of qualifications
- Interview results of shortlisted candidates including scoring
- Competency Assessments and the results on all shortlisted or where applicable
- Report on full background and reference checks (work references, credit and criminal etc.) must be performed for all shortlisted candidates
- Appointment of successful candidates will also be subject to a clean criminal record as well as vetting where applicable and or limited to financial positions
- Ensure that a representation from organised labour to be afforded observer status during the interviewing stage and observer report id provided where necessary
- Unsuccessful shortlisted and interviewed candidates should be informed (in writing) of the results of the selection interview.
- Reasons why a particular candidate was not successful should be recorded in case the unsuccessful applicant asks for reasons for rejection.

2.3. DURATION

The duration of this contract is one (1) year based on performance which will be assessed and reviewed on a quarterly basis.

- 5.3 Bidders other than EMEs must submit their original and valid B-BBEE status level verification certificate or a certified copy thereof, substantiating their B-BBEE rating issued by a Registered Auditor approved by IRBA or a Verification Agency accredited by SANAS.
- 5.4 A trust, consortium or joint venture, will qualify for points for their B-BBEE status level as a legal entity, provided that the entity submits their B-BBEE status level certificate.
- 5.5 A trust, consortium or joint venture will qualify for points for their B-BBEE status level as an unincorporated entity, provided that the entity submits their consolidated B-BBEE scorecard as if they were a group structure and that such a consolidated B-BBEE scorecard is prepared for every separate bid.
- 5.6 Tertiary institutions and public entities will be required to submit their B-BBEE status level certificates in terms of the specialized scorecard contained in the B-BBEE Codes of Good Practice.

- 5.7 A person will not be awarded points for B-BBEE status level if it is indicated in the bid documents that

such a bidder intends sub-contracting more than 25% of the value of the contract to any other enterprise that does not qualify for at least the points that such a bidder qualifies for, unless the intended subcontractor is an EME that has the capability and ability to execute the sub-contract.

- 5.8 A person awarded a contract may not sub-contract more than 25% of the value of the contract to any other enterprise that does not have an equal or higher B-BBEE status level than the person concerned, unless the contract is sub-contracted to an EME that has the capability and ability to execute the sub-contract.
